

# **Index Methodology**

Nifty IPO Index aims to track all IPOs listed on NSE Main board and permitted to trade stocks if they are allowed to trade on NSE on the day of listing. Company's free-float market capitalization as on the listing date at NSE should be Rs. 100 crores or more

- The index has an inception date of Jan 02, 2017, with a base value of 1000
- Last 100 IPOs are eligible for inclusion in the index subject to minimum inclusion criteria
- The weight of each stock in the index is based on its free float market capitalization
- The index is reviewed quarterly
- Stocks weights are capped at 10% each

Index Governance: A professional team manages all NSE indices. There is a three-tier governance structure comprising the Board of Directors of NSE Indices Limited, the Index Advisory Committee (Equity) and the Index Maintenance Sub-Committee.
