Exclusion of Tata Motors Ltd. (formerly known as TML Commercial Vehicles Ltd.) from Nifty indices

NSE Indices Limited vide its press release dated October 07, 2025 had announced inclusion of Tata Motors Ltd. (formerly known as TML Commercial Vehicles Ltd.) with a dummy symbol "DUMMYTATAM" on account of demerger of company's commercial vehicles business from Tata Motors Passenger Vehicles Ltd.'s (formerly known as Tata Motors Ltd.) in various indices effective from October 14, 2025 (close of October 13, 2025). After the demerger, Tata Motors Ltd. (TMCV) was listed on November 12, 2025 at the National Stock Exchange of India Ltd. (NSE).

In accordance with the index methodology, as TMCV has not hit the price band on two consecutive trading days on November 12, 2025 and November 13, 2025 at NSE, the Index Maintenance Sub-Committee (Equity) of NSE Indices Ltd. has decided to exclude TMCV from various indices as listed hereunder effective from November 17, 2025 (close of November 14, 2025).

It may be noted that if TMCV hits the price band on November 14, 2025, the exclusion shall not be deferred further.
