### Replacements in indices

The Index Maintenance Sub-Committee (Equity) of NSE Indices Limited has decided to make replacement of stocks in various indices as listed hereunder. These changes shall become effective from August 30, 2024 (close of August 29, 2024).

#### **A. Exclusion of Tata Motors Ltd. 'A' Ordinary Shares - DVR:**

On account of announcement of record date (September 01, 2024) by Tata Motors Ltd. ('Company') for implementation of scheme of arrangement involving reduction of capital of the Company by way of cancellation of the entire 'A' Ordinary Shares (shares with differential voting rights) and issuance Ordinary Shares as consideration for such reduction of capital, Tata Motors Ltd., 'A' Ordinary Shares - DVR (Symbol: TATAMTRDVR) shall be excluded from the following indices:

Consequently, the equity shares and investible weight factor (IWF) of Tata Motors Ltd. (Symbol: TATAMOTORS) shall be revised based on the terms of shares exchange ratio w.e.f. from August 30,

2024 (close of August 29, 2024) and shall be reflected in the indices that are computed based on market capitalization methodology.
