Corporate Action Adjustment for Hindustan Unilever Ltd. in Nifty indices

NSE vide its circular NSE/CMTR/71508 dated November 27, 2025 has announced special pre-open session to be conducted for Hindustan Unilever Ltd. (HINDUNILVR) in Capital Market segment on December 05, 2025 on account of demerger of company's Ice Cream business into Kwality Wall's (India) Ltd.

In accordance with the index methodology, demerged entity Kwality Wall's (India) Ltd. (with a dummy Symbol "DUMMYHDLVR") shall be included at zero price without divisor adjustment in following indices effective from December 05, 2025 (close of December 04, 2025).
